

Norfolk and Suffolk Devolution Agreement

At the full council meeting on 29 June 2016, NNDC decided not to back the Norfolk and Suffolk Devolution Agreement. This was accepted at a Cabinet meeting immediately after the full council meeting. Consequently North Norfolk will not be part of the “devolution deal”.

NNDC Ward Boundary Review

The Local Government Boundary Commission for England – following a submission from NNDC – are minded to recommend a reduction in the number of NNDC Councillors to 40. Public consultation is open until 5th September 2016. Please see the poster below for details.

North Norfolk Big Society Fund

In the latest round of Big Society Fund grants have been agreed for two groups in Priory Ward:

- Stiffkey Parish Council (£572) so the Parish Council can fence off land they have recently leased for use as an allotment site. They will also buy a communal shed.

- Stiffkey Social Services Committee (£8,770) to buy and install play equipment and safety surfacing.

Voluntary and community organisations within North Norfolk may apply for Big society Fund grants to support their projects. The Commission has also announced that 40 councillors should be elected to the council in future: eight fewer than the current arrangements.
